

The Anna Rennie Chapter

Formed in 2006, the Anna Rennie Women's Chapter of the Port Adelaide Enfield Chamber of Commerce was named in honour of a truly inspiring local woman.

Anna Moir Rennie studied nursing at the Adelaide Hospital and, during the 1920s and 30s campaigned for improvements to the food ration scheme in Port Adelaide, later, directing attention to women's issues such as equal pay. As SA's first female elected Councillor, she served on the Port Adelaide Council for 19 years – the last 5 as Mayor. In council she promoted significant improvements to local roads and footpaths, the setting up of Elderly Citizens' Clubs and children's playgrounds, and the purchase of land to enlarge many parks and ovals. She was instrumental in the establishment of the first Meals on Wheels in Australia, at Port Adelaide and low cost housing for homeless people affected by WWII and the post war depression.

Anna forged strong relationships with the local business people because of her genuine community spirit and ability to roll up her sleeves and get things done. Despite living in humble conditions, Anna took great pride in her personal presentation and carried herself with dignity. St Vincent de Paul society

The St Vincent de Paul Society's 40,000 members and volunteers work hard to assist people in need and combat social injustice across Australia. Internationally, the Society operates in 130 countries and has over 950,000 members.

The first Australian conference was founded in Victoria by Fr Gerald Ward at St Francis' Church, Melbourne on 5 March 1854, just 21 years after the founding of the first conference in Paris.

The Society in SA currently has over 2500 members and volunteers in 64 Conferences, 37 Vinnies Centres and numerous Special Works. They all work together with State Administration and the Kidman Park Distribution Centre to relieve not only the immediate needs of the poor but to identify the deep and long-term causes leading to spiritual, financial and social hardship in our community, and provide a voice for the disadvantaged.

The Anna Rennie Chapter and St Vincent de Paul have a partnership project in Port Adelaide known as "Dressed for Success" through which business women donate pre-loved corporate clothing for redistribution to women just starting out. The clothes are recycled through the Anna Rennie Boutique located at the St Vincent de Paul shop at 263 St Vincent St Port Adelaide.

Councillor Carol Martin

For the past 12 years Cr Carol Martin has served the local community of Enfield and Kilburn as an elected member of the Port Adelaide Enfield Council. Carol is a business woman in the construction industry working as Director of SA Shoulder Pavers Pty Ltd and Part-Owner of PC Truck and Plant Hire Pty Ltd. She is a foundation member of the Anna Rennie Chapter and tireless worker for her community. As a patron, board member and/or active volunteer of nearly 20 community organisations, Carol epitomises the Anna Rennie spirit.

Carol's sponsorship of this millinery competition aims to draw attention to the Ovarian Cancer Challenge Charity, of which she is Patron. Ovarian cancer is often referred to as a silent killer because its symptoms can be vague and part of everyday normal life. Each year in Australia about 1200 women are diagnosed. More than 70 per cent of these are diagnosed at an advanced stage because there is no screening test and because most women are unaware of the symptoms. www.ovariancancerprogram.org.au

COUNCILLOR CAROL MARTIN MILLINERY COMPETITION

CONDITIONS:

1. These terms and conditions (Terms and Conditions) apply to each competitor (Competitor) who submits the entry form entitled 'Councillor Carol Martin Millinery Competition 2011' (Competition). The Competition requires each Competitor to submit millinery works for consideration, exhibition and a panel review as described on the entry form (Millinery Entry).
2. Each Millinery Entry must be the original work of the Competitor.
3. The Competitor warrants that the Millinery Entry submitted does not infringe any trademark, copyright or the intellectual property rights of any person or entity.
4. Competitors entering the Jayne Warnes Youth Award must be aged 15 years or under on 5-11-2011.
5. Attached to the inside of each Millinery Entry and clearly written must be the:
 - a. Name and address of the Competitor;
 - b. Title of the entry
 - c. Competition Category Entered;
 1. Open
 2. Business
 3. Jayne Warnes Youth Award
 - d. Age; if entering the Jayne Warnes Youth Award, and
 - e. Price for the sale of the Millinery Entry.
6. If the Competitor does not desire their Millinery Entry to be sold, they must clearly mark any such Millinery Entry as 'not for sale'.
7. Each Millinery Entry must be left at or consigned to St Vincent De Paul, 263 St Vincent Street Port Adelaide SA 5015 (SVDP) by 4:00pm Tuesday, 4 October 2011. The Competitor will be responsible for all costs associated with submitting the Millinery Entry to SVDP and expressly agrees that the Anna Rennie Chapter, Port Adelaide Enfield Chamber of Commerce (PAECC) and SVDP will not in any way be responsible for the costs associated with the freight, postage or other charges incurred in the delivery or return of any Millinery Entry. A fee of \$20 per entry must be paid with the Entry Form in exchange for a competition materials bag. Accepted forms of payment are cash, cheque or money order made out to 'Port Adelaide Enfield Chamber of Commerce'.
8. An additional fee of \$18 for postage and handling will be required and payable with the entry fee for Competition material bags which are to be posted to the Competitor. The PAECC will exercise all reasonable care in posting any Competition material bags to the Competitor, but will not accept responsibility for any loss or damage of posted material.
9. The Competitor expressly grants to PAECC the right to:
 - a. refuse to display or remove from display any Millinery Entry without being required to provide any reason; and
 - b. exhibit and showcase any Millinery Entry for the period of the Competition Exhibition.
10. In the event the Competitor does not wish to have the Millinery Entry exhibited, displayed or showcased in the Competition, the Competitor must give 48 hours written notice requesting such removal to PAECC.
11. The PAECC and SVDP will exercise all reasonable care with each Millinery Entry submitted but will not accept responsibility for loss or damage while they are in its custody. Packaging should be suitable for return and the Competition entrants are required to pay all charges incurred in sending and/or returning the Millinery Entry.
12. Winners will be announced at the Anna Rennie Chapter 'Adventures on the High Tea', Friday, 7th October 2011 between 4pm and 7:30pm. The winning entry of the Open category will receive a cheque for the sum of \$500. Two runners up will each receive a cheque for the sum of \$100 and a gift voucher to the value of \$50 redeemable for goods at SVDP. The winning entry from the Business Category will receive a 90min Coaching Voucher to the value of \$350 redeemable from Get Real Coaching. Runner up will receive a voucher for the choice of either a remedial massage or facial, redeemable from Beau Monde beautiful people Value \$70. The winning entry in the Jayne Warnes Youth Award will receive a \$50 gift voucher redeemable for goods at Port Art Supplies.
13. A 25% commission will be charged on any Millinery Entry sold and will be donated to SVDP.
14. Unsold Millinery Entries and those marked 'not for sale' must be collected from SVDP during normal business hours in the week starting Saturday 5th November 2011. Final collection is to be by 4:00pm Saturday, 12 November 2011. Items not collected by 4:00pm Saturday, 12 November 2011 will be considered abandoned and/or the title to those items will vest immediately in SVDP.
15. The Competitor agrees that PAECC and SVDP are under no obligation to exhibit, promote, advertise or sell any Millinery Entry or any associated items and that each competitor will indemnify PAECC for any loss or damage PAECC suffers due to a breach of these Terms and Conditions by the Competitor.
